## **ROYALTY-FREE END USER LICENSE AGREEMENT**

### **TERMS AND CONDITIONS OF USE**

MoonFloss® Productions, Inc., dba CelebrateGreece.com, hereby grants to its Client, herein referred to as Licensee ("Licensee") and its successors and assigns the non-exclusive rights to incorporate and use the Footage, Photo(s) or Content, (all CelebrateGreece.com materials collectively referred to as "Imagery") as specified on the Invoice on reverse side of this License Agreement ("Invoice") and on the terms and conditions contained herein. This nonexclusive, non-transferable license to use Imagery is subject to the following terms.

#### **USE**

1. Imagery may not be used in any way, and no rights are granted, until payment of all fees stated on the Invoice(s), and any other applicable fees or costs. Licensee's right to use same shall be only on the terms specified herein.
2. Imagery remains the property of CelebrateGreece.com and/or the copyright owner. A license only is granted to use the Imagery for the use specified on the Invoice and for no other purpose. Licensee does not acquire any right, title or interest in or to any Imagery or other licensed material, and will not make, authorize or permit any use of the Imagery or other licensed material other than as specified herein. Full credit and copyright information must remain with file. CelebrateGreece.com will receive appropriate credit when credit is given to vendors of similar services, such as other Imagery providers. (see section 12 below)
3. CelebrateGreece.com has the right to grant the rights specified herein. CelebrateGreece.com agrees to license Imagery only on the condition that Licensee agrees to use it in the specific context set forth herein. Any use by Licensee (or third parties) other than the use herein permitted is a material breach of this Agreement and entitles CelebrateGreece.com to immediately rescind this license.
4. LIQUIDATED DAMAGES. THE RIGHT TO USE IMAGERY IS VALUABLE. LICENSEE AGREES THAT IT WOULD BE DIFFICULT AND IMPRACTICABLE TO DETERMINE THE VALUE OF SUCH RIGHT AND, ACCORDINGLY, LICENSEE AND CELEBRATEGREECE.COM AGREE THAT THE REASONABLE LIQUIDATED VALUE OF THE RIGHT TO USE THE IMAGERY AND THE ENTIRE LIABILITY AND LICENSEE'S EXCLUSIVE REMEDY OUTSIDE THE SCOPE OF THE LICENSE GRANTED HEREIN IS ONE (1x) TIMES THE LICENSE FEE FOR THE IMAGERY.
5. Licensee may not sell, rent, lend, sublicense, or otherwise transfer any Imagery or the right to use or reproduce Imagery, and will take all commercially reasonable efforts to prevent third parties from doing same.
6. Imagery may not be used for any pornographic, libelous, defamatory or other unlawful purpose; or in a manner that would tarnish, damage or harm the rights of another; or as a trademark or service mark; or in violation of the trademark or copyright rights of others. No model releases or other releases exist on any Imagery unless the existence of such release is specified in writing by CelebrateGreece.com. CelebrateGreece.com gives no rights or warranties with respect to the use of names, trademarks, logo types, designs or works of art depicted in any picture, or the registrations or copyrights thereof, and Licensee must satisfy itself that all necessary rights, consents or permission as may be required for reproduction are secured.

### **GENERAL PROVISIONS**

7. All rights not specifically granted herein to Licensee are reserved for CelebrateGreece.com's use and disposition without any limitations whatsoever.
8. You agree to indemnify and hold harmless CelebrateGreece.com, Inc. and all of its officers, directors, employees and agents ("Those Indemnified") for ANY and ALL, costs, expenses, claims, losses, damages, liabilities, claims, costs or expenses, including attorneys' fees, incurred directly or indirectly by those Indemnified in connection with the use of the content and/or stock footage. CelebrateGreece.com shall in no way be liable for any special, indirect, consequential, punitive, or incidental damages (including, without limitation, damages for loss of business profits, business interruption, loss of business information, or any other pecuniary loss) arising out of the use of or inability to use any clips in the

CelebrateGreece.com footage collection. CelebrateGreece.com shall indemnify Licensee against all claims relating to or arising from the CelebrateGreece.com warranty that it has the right to grant the rights specified herein.

**9. No footage may be resold as an individual footage or as part of a stock footage package. No footage may be posted on a website for a free or as a paid download. No footage can be given away, other than by CelebrateGreece.com.**

10. This contract contains all the terms of this Agreement concerning use of Imagery, and no term or conditions may be added or deleted unless made in writing and signed by both parties. These terms and the terms of any subsequent invoice/copyright license supersede any and all prior agreements and understandings pertaining hereto.

11. Unless specified on Invoice, payment is expected before access is given to full resolution footage.. Any claims for adjustment or rejection of terms must be made to CelebrateGreece.com within ten (10) days after receipt of invoice. CelebrateGreece.com offers no kill fees or refunds on Imagery ordered.

**CLAIMS OR DISPUTES**

13. Any and all disputes, with the exception of copyright claims, arising out of, under or in connection with this Agreement, including, without limitation, the validity, interpretation, performance and breach hereof, shall be settled by arbitration in Santa Barbara, California, pursuant to the rules of the American Arbitration Association. Judgment upon the award rendered may be entered in the highest court of the State having jurisdiction. This Agreement, its validity and effect, shall be interpreted under and governed by the laws of the State of California. If CelebrateGreece.com is caused to present claims or suit as a result of any breach of the above terms set forth, it shall be made whole by Licensee for such reasonable legal fees or costs.
